Safety Signs Checklist

This checklist can be used to help carry out a safety sign survey of your premises. Although not extensive, it has been designed to help highlight any clear gaps in your current set-up and identify the relevant products to help ensure compliance with British and International Standards. **Upon completion of the checklist, if any of your answers are NO then use the page reference to find the recommended signs to rectify the issue**. You should check the condition of existing signs and replace any that are showing excessive wear and tear, display old symbols or where the graphics are fading as this may make them difficult to read. Look for consistency in terms of graphics / text format to maximise comprehension levels and minimise any risk of uncertainty.
